This course is endorsed and supported by the Construction Industry Training Board (CITB) and provides some support for eligible students under the Doorways2Construction program.

Successful completion of this unit of competency will support students as they prepare to undertake Workplace Learning in the construction industry. The White Card is recommended for all students studying Construction Pathways and is a mandatory unit of competency in the Certificate II Electrotechnology (Career Start) and Plumbing (Pre-Apprenticeship) qualifications.
